Centrally supported and approved tools are those for which we have negotiated terms of service to ensure, among other things, the appropriate protections for privacy of our students' data.

We realize that the educational software market is evolving rapidly. We also recognize that teachers want to creatively use additional technology tools in support of student engagement and student outcomes, and we support these efforts.

To remain compliant with federal laws including COPPA and FERPA, and protect the privacy of your students' data, please obtain parental consent when using a tool that is not on the district approved apps list.

The attached Parental Consent template should be used whenever using an online software tool that is not on the DPS approved apps and tools list.

What Should You Do?

If using a software tool that is not on the DPS Approved Apps List

1. Complete the attached Parental Consent form by including:
 - The name of the app or website that you would like to use in the classroom
 - The purpose of the app or website
 - The website URL
 - The information that the website collects (or a link to its privacy policy and terms of service)
 - Your contact information
2. Collect signed permission forms from your students
3. Retain the signed permission forms for the duration of the school year

Before using this tool, we wanted to make you aware of federal laws and regulations that apply to the use of technology to support classrooms and require parent consent in order to be most effective.

In order for me to use this online tool with student records or other information that could be personally identifiable, the Family Education Rights and Privacy Act (FERPA) requires that I obtain your consent due to the possible exposure of your student's information to the website's operator or to other participants. In order for students to use this program/service, certain personal information must be provided to the web site operator. Under the Children's Online Privacy Protection Act (COPPA), these websites must provide parental notification and obtain parental consent before collecting personal information from children under the age of 13. Schools are permitted to consent to the collection of personal information on behalf of parents of students, thereby eliminating the need for individual parental consent given directly to the web site operator. Before doing so, the District is providing you with this notice and opportunity to opt out.
